## Part A: Pupil premium strategy plan

#### Statement of intent

Pupil Premium was introduced to address the underlying inequalities between children eligible for free school meals and their peers. It is allocated to schools to work with pupils who have been registered for free school meals at any point in the last six years. Schools are free to spend the Pupil Premium as they see fit, however our approach and vision for our pupils is to ensure that all are offered 'rich opportunities and memorable experiences' and that those from poorer socio-economic backgrounds do not suffer barriers which hamper their progress and attainment.

At Stratford upon Avon Primary School our intention is that all pupils, irrespective of their background or challenges make good progress and achieve high attainment across all subjects.

The objectives of our pupil premium strategy are:

- To narrow the attainment gap between disadvantaged and non-disadvantaged pupils.
- For all our disadvantaged pupils to make at least nationally expected progress
- To support our children's health and well-being to enable them to flourish.

#### Identification:

• Pupil premium students are identified from the January pupil census.

#### Yearly Cycle:

- Once identified, an initial autumn term meeting will be held with class teacher to establish how pupil outcomes can be raised. Parents will receive a letter outlining how pupil premium will be spent and if necessary a bespoke meeting will be held
- A mid-year meeting will be held to discuss the impact of current strategies and may include parents, pupil and teachers views and future steps.
- An end of year meeting will be held with current class teacher and new class teacher to discuss end of year outcomes.

#### Strategies:

Some children need high quality, tailored support

Some may benefit from attending clubs they would not be able to access such as swimming lesson, football clubs and dance

Pupil premium children benefit from high-quality teaching and learning

Pupil premium children benefit from outdoor learning to build self-esteem and confidence Adaptive teaching and learning opportunities

Help parents with wrap around care so that parents can work, breaking the cycle of disadvantage Leaders identify training that will continue to provide the best opportunities for all pupils e.g. staff continue to receive training around inclusive practice, challenging education and Early Help and how to communicate effectively with parents and families.

All teachers are aware of the pupil premium pupils in their class and plan accordingly with support and challenge so that they have the same opportunities as their peers.

The outcomes of the pupil premium students are discussed case by case at pupil progress meetings and parents evening

To maximise effectiveness, we will act early and adopt a whole school approach in which all staff take responsibility for disadvantage pupils' outcomes and raise expectations of what they can achieve.

# **Challenges**

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

## Part B: Review of the previous academic year

### **Outcomes for disadvantaged pupils**

#### Quality of teaching impact

EYFS GLD Levels for PP Children (3) – 66% Met Expected Standards. One child has social and emotional needs and undiagnosed ASD.

Year 1 Phonics PP Children (4) 75% passed phonics screening check — impact of Little Wandle Phonics teaching and regular assessment. One child is LAC with significant delayed speech and trauma.

KS1 Statutory assessments for PP children (2) Reading = 100% Writing = 100% Maths = 100% Impact of maths and reading programmes and regular assessment.

KS2 Statutory assessment for PP children (7)

Reading = 100% Writing = 57% Maths = 71%

Writing – 3 children had significant special educational needs which affected ability to write.

#### Actions -

Continuous assessment throughout the year, Identification of children requiring support and interventions put in place; Pupil progress meetings taken place to identify next steps. Predictions made and revisited. Times table rockstars, precision handwriting and spelling lessons, reading recovery sessions. Maths Mastery lessons embedded. Regular discussions about pupils. Engagement with parents to ensure pupils make progress.

Consistent approach to the teaching of all areas of the curriculum resulted in high quality learning and high expectations.

Forest school sessions for PP pupils improved their focus, self-esteem and vocabulary.

# Targeted Academic Support and intervention Impact

Teaching Assistants assigned for each classroom to support pre-teaching, consolidation teaching; class-based interventions and small group work interventions.

Origin Maths hub collaborative work resulted in improved mathematical knowledge and skills.

### **Further information**

This academic year we continue to work with PINS (Partnership for Inclusion of Neurodiversity in Schools). This is to strengthen our relationships with parents even further and to signpost and support in accessing a wide range of services that is available to them.

We have a new English Lead who is experienced in improving outcomes for Pupil Premium children.

We regularly update our pupil premium at a glance document to ensure good communication and monitoring.
